## **PRIVACY POLICY**

Provision of Customer Information: Legal Basis and Purpose of Use

We collect information about you to ensure our customer support and utilize various types of information, including your personal data, contact information, identification archives, budgetary data, significant documents, and other data.

Furthermore, we use your information for risk administration, prevention of tax evasion, and compliance with administrative and legal requirements. We process financial and personal information for these purposes.

We also use your contact details, consent, and correspondence for marketing notifications about our services. We rely on legal grounds related to fulfilling contractual obligations to you. We strive to ensure transparency and protection of your rights during the processing and use of your data.

What informational data can be disclosed to third parties?

- 1. We strictly do not disclose informational data to organizations, associations, or other individuals unless it is necessary for the following purposes:
- 2. Compliance with mandatory and significant legislative requirements, principles, and norms, as well as government demands.
- 3. Application of regulatory acts to identify violations and resolve conflict situations.
- 4. Ensuring security, fact identification, and taking measures to prevent potential issues. Protection of the rights, interests, and safety of the company, its clients, and other individuals in accordance with the law. We may provide data about aggregated users of our website to third parties for analysis and identification of general usage trends of our platform. If the company engages in consolidation, sale, or transfer of assets, we guarantee the confidentiality of information and data of our users until the moment of transfer or transmission to the new owner. Our company does not disclose the name, email address, or other user data to third parties.

In some cases, we may transfer your personal information to another country for additional processing in accordance with our privacy policy. This may involve exchanging information with countries where data protection laws may differ from those in your country. However, we ensure that your rights are sufficiently protected in accordance with legal requirements and premises. We employ specialized, coordinated, and authoritative legal measures to ensure the security and confidentiality of your data.

## What rights does the client have?

- 1. Right to access personal information: You have the right to request and obtain a copy of your personal information that we process.
- 2. Right to rectification: If you believe that your personal information processed by us is incorrect or incomplete, you have the right to request us to correct or supplement that information.
- 3. Right to data portability: You have the right to request that we transfer your personal information to another controller of your choice. You may also request a copy of all your personal information that we process.
- 4. Right to withdraw consent: You can withdraw your consent for the processing of your personal information at any time by clicking on the "Unsubscribe" or "Withdraw" button in the marketing emails we send.
- 5. Right to restriction of processing: You have the right to request that we cease processing your personal information if you believe that the processing is unlawful or that your personal information is no longer necessary for our purposes.
- Right to object: You have the right to object to the processing of your personal information at any time if you believe that such processing infringes upon your rights and freedoms.
- 7. Right to erasure: You have the right to request that we delete your personal information that we process if there are no legal grounds for further processing.
- 8. Right to lodge a complaint: If you believe that we have infringed upon your rights regarding the processing of your personal information, you have the right to lodge a complaint with the data protection authority in your country.

## Confidentiality and Automated Decisions: Your Protection

When we use your personal information, we sometimes employ automated decision-making processes that may have a legal impact on you or significantly affect you in other ways. An automated decision is a decision made in a natural manner based on computer calculations without human involvement.

For example, if we use an algorithm to show you advertisements based on your internet search history, this can be an example of an automated decision.

If we use an automated decision that concerns you, and you are concerned about its impact, you have the right to contest that decision. You can provide us with your thoughts and request that we reassess our automated decision with the assistance of a human to ensure that it does not contradict your rights and interests.
